Clerk had reply from One Voice Wales who confirmed that there was no statuatory obligation to produce a business plan however members felt that in order to safeguard the reserves a business plan was required and would include

- improve access to cae nant better visibility
- segregate pedestrians and cars on the main access
- improve the surface to what was being used as car park
- grasscrete type product to improve access to green area along the part used as a football pitch
- energy efficiency measures to cocoa rooms

6. Digital

John Mc Guire had meticulously specific what was required which reflected in the following tenders being received

Boyns Ruthin £2862.00 inc vat

Catalyst Denbigh £2816.30 inc vat

It was decided to ask the full council for permission to accept the lowest quotation'

The members of full council were generally in agreement with what was minuted above however felt that additional play equipment to Cae Nant should be included In the business plan

Cllr Evans enquired about the auditors bills received recently however the Clerk reported that although he had challenged the bills nothing further had been heard however they would probably be re presented.

13 .Request from Shop Team

"As you are aware progress is being made towards refurbishing and reopening the village shop and post office which will also include a small community hub.

It is hoped that many local people will walk or cycle to visit the premises and we will be actively encouraging low/no carbon forms of travel. We recognise, however, that passing trade and/or less mobile individuals will choose to drive to the shop and that parking in the centre of the village is problematic.

We would like, the Llandyrnog Community Shop and Post Office to suggest or even be able to direct shoppers/visitors to the parking alongside the Pavillion to reduce risk of adding to congestion on or near the crossroads. Mindful of the fact that this car parking is not the property of our project we would like to ask the Commuity Council if it is willing for us to promote parking at the Pavillion to our customers? We would welcome a conversation about what form such 'promotion' might take and what approach would be regarded as appropriate'

Neither Cllrs Morris or Mc Guire took part in the discussion having declared their interest.

The points made for and against were as follows:

The Shop Team members present felt that since the shop was owned by the Community it was felt that the Community Council should support the request

The responses received from members were varied;

- Request had been made in the past by residents but had been refused on safety grounds and also it would go against the main aims and objectives of the Charity of providing play area and not a car park
- A point was made that the area would need to be surfaced, bays marked out and safe passage to separate children and cars and a full risk assessment carried out
- By allowing the area to be used a car park the community council's exposure to a claim by a third party would be greatly increased the area would not be very well lit for example
- It may set a precedence

There are stakeholders to consult and Cllr Parry had already approached the Llandyrnog Sports and Football Association and to date no response received

If stakeholders had concerns mirroring the above the Clerk would respond wishing the Directors well with the venture however the council would not be able to allow cae nant to be used as a car park.
