An enquiry had been made by the Community Council aboutt the recorded road traffic accidents around the Waen/Green/Brynllys area over the past twelve months and PCSO Jones confirmed there had been four over the twelve months January, February, May and January 2023 but luckily there had been no injuries

There was concern about the speed of traffic along that stretch of road and Cllr Parry was going to see if DCC Highways would be willing to supply speed monitoring equipment and share the information with NWP

PCSO Jones confirmed that there had been reports of a suspicious vehicle in the area with the driver offering to undertake gardening work etc and thanked the public for being vigilant and reporting such incidents – helps the police to build up a picture.

There had been a daytime burglary into an insecure building on the Bodfari Road and PCSO Jones advised everybody to lock their buildings and invest in a basic security - camera linked to mobile phone, security lights, secure locks set up a what's app neighbour group so if a phone is alerted all neighbours can be contacted immediately

There had been two incidents with a rogue dog attacking other dogs in and around the village – the owner of the dogs that suffered did not wish to press charges and therefore the Police had limited powers save to offer advice to the dog owner

There were two incidents around the Llangwyfan area involving member of the public and resident out on exercise with carers – one was a physical assault the other extremely challenging reaction when advised they were on private land – MCH are acutely aware of the incidents and are in touch with the person affected and the matter will be brought up in the next Liason meeting
