There were concerns about the way the matter of possible issues with the Dog Care facility at Wern had been reported in Llais and that it may be prejudice the business however when the minutes were read out the speakers felt that it was a fairer reflection of the situation. It was explained that what was read were notes from the meeting and not the actual minutes however something had obviously been lost in the translation and Clerk apologised for this

The speakers did confirm however that following guidance from DCC they had installed noise monitoring equipment around the facility and that there were on going discussions between DCC and the operator with a view of submitting a planning application for change of use if DCC felt that was necessary. The operator confirmed that she had a licence to operate from the site and was working closely with DCC to ensure compliance

The CC did raise concerns about a lighting scheme however lighting is now covered by an SPG and trust the applicant will be advised accordingly that a suitable scheme of lighting should be submitted and approved prior to occupation
	Confirmation will be required from the Highways Officer that the amount of traffic

generated will not be detrimental to the free flow of traffic along this narrow lane. Despite serious concerns about this the CC
does support the application
