- 4. Speaker Dr Patricia Mc Kinnion Day
  - Dr Day gave the councillors an overview of the amendments to her application 18/2024/1545 following come concerns from the community council. The Planning Officer had met on site to discuss the amendments and was in agreement that the reduced scale was beneficial and would be recommending approval. The Community Council was content that their concerns had been addressed the only provisor was that the heigh boundary between the Old Coach House and The Stables be maintained to protect the amenity and privacy of both parties. It was explained that since David Davies had retired this post had been vacant but it was good to have a stronger link between the community and county council

Also interesting was projects being undertaken by other community and town councils which included

Llandudno – looking for funding regarding taking over of public toilets. Have had an

Ombudsman case to deal with. Have grass cutting groups.

Abergele – trying to sort out toilets and fighting to keep free parking areas. Have a Fun Day on 6th July.

Cefn Meiriadog – Still have major concerns around extensions to sub stations and Solar farms- struggling to prevent further expansions to the infrastructure, and don't get any support from Denbighshire Council.

Lansannan – have been running the toilets for some time and are deemed the best in

Wales. They have a visitors' book in the ladies' toilets which would support that view.

They are run by volunteers who have the upmost pride in their work. They have been in discussions with the County Council since before Covid about taking over a play area and nothing has happened to date. They have decided not to renew the lease on the pavilion and are trying to get yellow lines put down in some areas.

Llanefydd – Have just taken over the toilets, they are on the pilgrim's trail so important o have facilities for walkers. They have extended the pavement from the village to the playground. Currently looking into reducing speeding through the village.

Bodelwyddan – the warm hub is still going strong which meets every Tuesday with 10- 12 attending. They are taking over the park through funding from the Levelling up fund.

Prestatyn – Warm hub has 30-40 a week from Oct – July with a different community centre hosting on different days. Concerns about shops closing and encouraging a Coach friendly Prestatyn to help with footfall. Levelling up fund to be used to do something on the high street. Need to find a way to connect the retail park to the high street.

Henllan – Warm space offers a 2 course meal

Llandyrnog – Preparing a biodiversity plan, have an allotment project in conjunction with Denbigh CC. Currently looking into provision of playground equipment suitable for children/adults with disabilities.

Corwen – trying to get coach friendly status
