Feasibility study it was decided by a vote that £1000 be included in the 2023/2024 budget as a contribution towards a community needs survey to be enabled by Cadwyn Clwyd – this would give a clear focus as to the aspirations of the residents

Llangwyfan notice board – there was a meeting of the Highfield Park Liason Group shortly and the matter would be brought back to council following that meeting

Church Notice Board – not the responsibility of the Community Council – Merfyn to raise matter with DCC Countryside Services who had kindly donated and erected the notice board

Cllrs Griffith and Butler had represented the Community Council at the Proclomation Ceremony at Ruthin on Sunday 11th September and were thanked for giving their time to represent the Commuity at such a memorable event.

11. Members Items

Concerns about dogs fouling around the play area in cae nant – it was generally felt that this was caused by dogs that were just unattended however matter to be raised in Llais and social media and additional signs being made.

Also concerns about dog faeces bags being left on fences and hedges around the Llangwyfan area – matter to be highlighted in Llais

Entrance to cae nant – could this be improved – this question to be included in any future community needs survey

Road Improvements – members to consider which roads or lanes warranted re surfacing and relay to ClIr Parry so that the Officers can draw up a list of priorities in any future resurfacing programme

Energy use – the Council to be mindful of the rise in electricity prices and budget adjusted accordingly – Clerk advised that the Council were currently in credit and it was decided to leave he account in credit.

Give way sign – Ty Capel Isaf – had been damaged by hedge cutting again – report to DCC

Concerns about state of vacant properties – Kinmel Terrace, 2, 4 and 5 Church Square, Brookside – since there was uncertainty about the ownership it was decided to forward the CC concerns to DCC's empty homes officer via the Head of Planning Services
