Community Policeman:

PCSO 3476 was present at the meeting and confirmed that following the last meeting they had collated a list of the largest agricultural contractors covering the area and were more able to deal with issues relating to matters relating to concerns about the speed of these vehicles through the rural areas.

PCSO also confirmed that they would be visiting Cae Nant over alleged conflict between visiting team supporters and local residents – situation of concern to community council and to be monitored.

- Route 76 - organising committee had discussed the concerns and attempts would be made to ensure that stewards at next event would be more identifiable possibly via high viz gear.
- Blocked Gullies around Glan y Wern – matter seen too.
- Bus Stops – Highfield had completed painting two bus stops – Clerk to contact to thank Sian and her Team for their work
