

**This nomination pack is for use by candidates who are standing at a local government election in Wales**

**The following papers must be delivered to the Returning Officer by hand or electronically:**

1a: Nomination paper

1b: Home address form

**The following papers can be delivered by hand, electronically or by post:**

2: Certificate of authorisation

3: Request for a party emblem

4: Notification of election agent

The notice of election published by the Returning Officer will specify the place and times that nomination papers may be hand delivered and the arrangements for delivering nomination papers electronically.

If you deliver your nomination paper by hand, you must submit the **original signed version** of each completed paper.

**General Data Protection Regulation (GDPR)**

Data protection legislation applies to the processing of all personal data. Please contact the [Information Commissioner's Office](#) for further information about how the General Data Protection Regulation affects you.

You should point out to the person who witnesses your nomination what the information on the form will be used for and how personal data will be processed and kept secure. The lawful basis to collect the information in this form is that it is necessary for the performance of a task carried out in the public interest and exercise of official authority as set out in Representation of the People Act 1983 and associated regulations.

You should also explain that the information will be shared with the Returning Officer. For further information on data protection and data processing you should refer to the Returning Officer's privacy notice on their website.

This checklist is designed to assist candidates standing in a principal area local government election<sup>1</sup> in preparing to submit their nomination, and should be read alongside the Electoral Commission's [Guidance for candidates and agents](#).

If a registered party name does not include ‘Wales’ or ‘Cymru’ or ‘Welsh’ or ‘Cymreig’ then the registered party name may be supplemented with ‘Wales’ or ‘Cymru’ or ‘Welsh’ or ‘Cymreig’ in the description box.	
Others can use ‘Independent’ (and/or ‘Annibynnol’ in Wales) or leave this blank. Whatever you enter in this box will appear as your description on the ballot paper.	
<b>Section 4 – Candidate’s statement of party membership</b>	
Indicate whether you have been a member of any registered political party at any time during the period of 12 months ending with the day on which the notice of election is published.	
Add the name of each registered political party you have been a member of and the dates of membership during the relevant period. However, only add if you have been a member of a political party other than the one you have provided a description for on your nomination paper.	
<b>Section 5 Declaration</b>

You must be a British citizen, an eligible Commonwealth citizen, a citizen of any member state of the European Union or a qualifying foreign citizen and not require leave to enter or remain in the United Kingdom or have indefinite leave to remain. You must also be 18 years old or older on the date you sign this form.	
You must meet at least one of the listed qualifications (a, b, c or d). Indicate which one or more of paragraphs (a) to (d) apply by placing a tick in the box next to them and putting a line through those that do not apply.	
You must not sign the form if you are disqualified to stand. Make sure that you read the

### **Notes to the form of nomination paper**

Note 1: The date to be given here is the date on which the poll is to take place

Note 2: If a candidate commonly uses forenames or surnames that are different in any respect from the forenames or surnames that are given in the first part of section 2, the candidate's commonly used forenames or surnames may be given in the appropriate place in the second part of section 2 if the candidate so wishes. This includes (but is not limited to) cases where the difference is that the commonly used forenames or surnames are in a different order, include only some of the names or include additional names. Where commonly used forenames or surnames are given, those names will generally appear in the statement of persons nominated and on the ballot paper (instead of any other names). There are circumstances in which the returning officer may refuse to use the commonly used names and these are set out in rule 14 of Schedule 1 to the Local Elections (Principal Areas) (Wales) Rules 2021.

Note 3: The only descriptions that may be given are (a) a description that is likely to lead electors to associate the candidate with a registered political party or with two or more registered political parties and is permitted under rule 6 of Schedule 1 to the Local Elections (Principal Areas) (Wales) Rules 2021 ("a permitted party description"), or (b) the word "Independent" or the word "Annibynol", or both those words.

In certain circumstances, a candidate using a permitted party description may add the word "Wales", "Welsh", "Cymru" or "Cymreig" to the description. Those circumstances are set out in rule 7 of Schedule 1 to the Local Elections (Principal Areas) (Wales) Rules 2021.

Note 4: The requirements for statements of party membership are set out in rule 8 of Schedule 1 to the Local Elections (Principal Areas) (Wales) Rules 2021.

Note 5: The first declaration reflects the requirements set out in section 79 of the Local Government Act 1972. That section defines "qualifying Commonwealth citizen", "relevant citizen of the Union" and "qualifying foreign citizen".

Note 6: When the nomination paper is delivered, it must be accompanied by the candidate's home address form which must comply with rule 9 of Schedule 1 to the Local Elections (Principal Areas) (Wales) Rules 2021.
