3.Declaration of Interest

4.Dementia Friendly Denbigh

Dilwyn Jones and Rebecca Bowcott gave a very interesting presentation on how Denbigh were aspiring to become a Dementia Friendly Town

That is the top status that can be achieved and described as a journey which includes encouraging residents to attend two meetings a month so they can be trained to become ' dementia friends' , the next step up being more formal training to become a dementia champion.

Rebecca and Dilwyn offered to attend Llandyrnog with a view to ensuring those wishing to do so could become dementia friends and it was decided to book a coffee morning in January and invite Rebecca and or Dilwyn along.

In terms of Denbigh becoming a dementia friendly town it involved businesses taking some ownership of the scheme – dementia sufferers tended to want to sit down a lot so chairs were encouraged in shops, ensuring no black mats, relaxed till in supermarkets, staff assisting sufferers with payment and change etc.

The local Police have been encouraged to adopt the Herbert Protocol where by they are given basic details of those suffering so that they can be easily identified and re united with family should they decide to wander.

There were aspirations to open a drop in café where carers could bring their partners along and leave them while they went shopping or appointments etc.
