<u>8 Planning.</u>

Members gave their views on the candidate sites submitted to DCC for inclusion in the new local development plan 2018/2033 in the Llandyrnog and Llangwyfan area.



The above site has already got outline planning application and members felt that it could be included as a candidate site for the 2018/2033 Local Development Plan



The above site seems to be behind a parcel of land that has not been submitted as a candidate site and therefore deemed to be landlocked and therefore cannot be supported – see below comments received from DC 31st July. For clarity the area referred to as area B is the land between the candidate site and the main road

On your map, the land marked with 'B' has not been submitted to us as a candidate site. It is also not a residential land allocation in the current Local Development Plan 2006 – 2021. Hence there is nothing to 'carry over' into the next Plan. There could be a merit in re-aligning the development boundary.

Nevertheless, the land marked with 'B' benefits from a valid outline planning permission for the development of 0.3 hectares of land for residential purposes. The outline application remains in place until January 2020, unless the applicant starts discharging reserved matters beforehand.

Basically, if the landowner was not confident that he is going to implement the current planning application he would be best advised to submit his land to the Council as candidate site as part of the current consultation.



The above site sits parallel with the existing Nant Glyd Estate and the Community Council would support this site providing the land is allocated on 50/50 affordable /open market housing and that the applicant would be able to demonstrate that he could achieve an access to the required highway standard by utilising some of the adjoining land.



The above site adjoins another candidate site referred to previously – the community council would be unable to support the application to have this land included within the LDP at the present time – it is felt that two sites in Llandyrnog would suffice for the current LDP.



Llangwyfan sites



Two sites have been been offered in Llangwyfan, however Llangwyfan is not a designated village and therefore does not have a current development boundary and as far as the CC is aware no proven exceptional need for housing on this scale.

It would therefore be deemed to be housing in open countryside and the absence of any evidence of need or necessity to live in the area would be contrary to current policy and the Community Council would not support any application to depart from that particular policy particularly considering that these sites are within the AONB and very limited infrastructure to support developments of this size.
