#### 6.00) Reports

Presentation by PC 1952 David Allen from Rural Crime Team given to One Voice Wales meeting at Denbigh 11<sup>th</sup> April attended by Clerk

PC David Allen has been an officer with the North Wales Police for 16 years. During his service with the force he has been stationed as a response officer in Colwyn Bay, Flint and Holywell. Previously he has been stationed in Mostyn along with a team of three PCSOs. His beat covered a large rural area where he had a large amount of daily interaction with the agricultural community.

Dave has first hand experience of the devastation to people's livelihoods that can be caused by the theft and damage of farm machinery and livestock. He appreciates the impact that such crime can have on our close knit rural communities, in terms of the economic costs and people's perceived fear of crime.

He has a degree in Environmental studies and previous experience as a wildlife crime investigator. Dave is currently learning Welsh and has attained level 3.

Based in Corwen DA is one of seven PC's throughout North Wales who dedicated to Rural Crime.

#### Their work includes:

Dealing with cold callers selling chainsaws, generators, tools etc that are purchased in Ireland on sale and return basis – quite often these cold calls are followed by thefts from farms

Hunting Act – hunting with dogs is still legal but with strict guidelines – only two dogs working etc – again difficult to prove with a pack of hounds. Scrap metal theft – dealers need to be licensed and can only operate in the county that has issued a licence they also need waste carriers licence Fly tipping – work closely with NRW to monitor hot spots – PC suspects that loads come in from Merseyside and Manchester down the A55 tipped and then back again

Theft of quads – most tractors have sophisticated equipment to prevent theft or track if stolen – quads have no such equipment as standard and easy targets Illegal slaughterhouses – quite a few been discovered in North Wales eastern European residents do not share same enthusiasm for food hygiene Dog attacks – 80% of attacks are caused by dogs that have escaped from gardens or houses not let loose by owners while out walking - huge problem Badger baiting becoming more of a problem – extremely cruel with both dogs and badgers sustaining serious life threating injuries – examples of badgers being caught alive and taken to cities where they are kept for illegal dog/badger fights in garage pits.
