Emphasis on training and every willing inmate would be give a job within the Prison in preparation for release.

The Prison Service were currently recruiting and would be employing a number of apprentices to ensure continuity of skills required to run a Prison

The Prison is intended to serve an area within a 50m radius of the site but for those from North Wales serving long sentences in prisons further away - would be their last posting before eventual return home.
