The Council Members wished to express their condolences to Cllr Thomas on the recent death of his father – Mr.H.Thomas of Ruthin – Clerk had sent card on their behalf.

1.0)Community Policeman – Sgt.Dave Nickels and PCSO Geraint Owen were present at the meeting to discuss any issues of concern. It was reported by Sgt Nickels that the speed around the village had been checked with a speed camera and the average speed was below the threshold that would warrant further monitoring or further action for the time being.

Sgt Nickels also advised that it would be possible to train volunteers in the use of a mobile speed check gun and if there was further interest he would be happy to take the matter further.

2.0)Confirmation of Minutes

It was proposed and seconded that the minutes as presented were a true record of the January meeting and signed by the Chairman

3) Matters Arising

3.1) Lease for Pavilion – had been discussed at the AGM on the 9th February and waiting for response – one or two concerns were raised at the AGM about the Disclosing and Barring Service(DBS) requirement.

- 3.2) Informal Play Area at Parc Ty'n Llan update by Cllr Parry legal work nearing completion
- 3.3) Lane from London Bridge to Moel Arthur no further increase in activity reported
- 3.4) Superfast Broadband meeting was held 18th January but generally the response to individuals by BT had been disappointing and an end date not confirmed although the aim is to complete the installation
- 3.5) Dog Fouling T.Wynne Evans had confirmed that following receipt of intelligence the Kingdom team would be making visits to the area and the situation to be monitored
- 3.6) Notice Board contrary to what was reported to the last meeting the notice board on the shop has had to be passed onto the new tenants and was not available for public notices Clerk to source new notice board
- 3.7) Website Cllr Mc Guire was making arrangement to meet Andrew Murgatroyd and would report back at next meeting.
- 3.8) Boundary between Cae Nant and Gladstone Terrace owner of 1 Gladstone Terrace attended meeting and gave the Members his view on the matter and it was also covered in correspondence.

The owner of No 2 had also sent in a letter but was not present at the meeting.

Mr Parry left the meeting in order that the members could discuss the matter impartially. It was decided that without a doubt the boundary between Cae Nant and Gladstone Terrace was the brick retaining wall (not the post and wire fence) – this at one time being higher that it was at present and that at some time that wall had been taken down and a the post and wire fence erected about 500mm into Cae Nant and that some encroachment (unintended and historic) had taken place.

It was decided to contact owners of No 1 an 2 Gladstone Terrace to advise that the councillors as Trustees would be willing to consider not taking further action providing they as owners of the land would be willing to concede to the fact that they had unintentionally encroached and that they - or any future owners of the properties - would forfeit their right to make a claim for the title of the land in perpetuity.
