## 3.00)Matters Arising

3.1) Lease for Pavilion – CC had asked for two additional clauses to be included

- If any member of the LSA&FC committee to take responsibility of a group of vulnerable adults and children it would become their duty to ensure they have the relevant DBS certification in place to be compliant with current legislation
- It will become the LSA&FC responsibility to ensure that any club hiring the MUGA and Pavilion has the relevant certification in place to be compliant with current legislation.

Cllr.Evans to discuss this amendment with the LSA&FC and report back.

3.2) Informal Play Area at Parc Ty'n Llan – Clerk had arranged for the area to be cut and hand cleared for the sum of £200.00. Clerk to seek price for killing off grass, rotovating and re seeding and also to inform nearby residents that the CC now owned and controlled the area and that it would be an informal open space. Clerk was given permission to have the grass cut regularly until such time as permanent solution had been found.

3.4) Ditch by Capel Dyffryn – to be included in a larger scheme of improvement aimed – storm gully to be installed by Cross Keys which hopefully would stop most of the water getting as far as Capel Dyffryn.
