- Bridge between Llandyrnog and Llanynys had been re opened
- Damaged style path 26 rear of Ty'n Caeau - had been reported unknown whether work had been carried out - Clerk to check.
- rainwater pipe to Cocoa Rooms - had been repaired.
- Footpath Co Ordiators - still no response from DCC - Clerk to organise meeting and invite DCC

Members Items:

- leylandii trees opposite Waen Crossroad bus Stop and in the garden of Glan Y wern Lodge were overgrown and encroaching onto Highway causing lorries to have to cross the white lines - Clerk to report to Highways.
- various road signs - Speddyd area, Pen y Mount area and Brynllys area required attention - some obscured some been turned around - Clerk to look into matter further and action accordingly.
- Hwylfa - DCC had promised scarring material to fill pot holes
- ponding on road between Speddyd Land and Cerrig Llwydion - it was decided to see whether or not a site meeting could be organised between DCC and representatives of CC to see whether a proper drainage scheme could be programmed such is the concern about this matter.
- matters of road safety in and around village square - this matter was raised again and Cllr Parry and Clerk confirmed that they had

met the former DCC road safety - John Williams - on site 2013 but Mr Williams was of the opinion officer on that it would be unwise to put in a drop kerb around the Clwyd House area - one would effectively be encouraging people to walk into oncoming traffic on a blind spot . It was decided to re visit the matter and see whether a new road safety officer may have a different view. Clerk to contact Marc Musgrave.

- Members wished to thank Bryn Davies for his work on the roundabout.

Any Other Business

- Clerk presented the Risk Assessment Policy and approved the document.
