Matters Arising

- Public Access Defibrillator (PAD) successful coffe morning had been held to raise the profile of this facility and the sum of £164.00 had been raised. The coffee morning was attended my Mr Mc Guire and Steve Williams who represented North Wales Fire and Rescue Service and more training will be 9arranged.
- T.Carr had promised to look into the situation regarding the missing sign at the roundabout
- Route 76 no concerns raised and the event well run with issues.

- Blocked Gullies around Glan y Wern had been seen too but overgrown verges and excess debris effecting their ability to cope. Clerk to relay to DCC
- signs advising people not to walk dogs on cae nant had been prepared and erected
