- White lines between Speddyd and Glanrafon had faded and needed attention relay to DCC
- 30mph sign on road by Speddyd Junction faded Clerk to relay to DCC
- Local Development Plan at what stage were the CC going to be consulted Clerk to make enquiries
- Housing Need Survey there was a degree of interest in carrying out a housing needs survey to ensure that the proposed developments in the village actually reflected the needs for affordable housing in the area and there was a feeling that the CC were not being proactive enough – Clerk explained that DCC did not contribute to the Rural Housing Enablers post and therefore there would be a considerable cost involved. Cllr Parry to see if Cadwyn Clwyd could fund a survey and seek any assistance necessary
- Play Equipment Clerk reported the slide had been vandalised and not fit for use but could be repaired and this work to be put in hand
- Clerk to arrange meeting on Cae Nant with Playquest as a scoping exercise and invite all members
- Concerns about condition of Brookside Clerk to relay to DCC
- Ironwork proud of tarmac around Groes Efo Cottage area report to DCC
- Members requested Clerk to contact Rev.Rowlands to see if there was a programme in place to repair Church wall
- Similarly the heras fencing was unsafe and this to be reported to Church and DCC it affecting the Highway
- Youth activities since there was no youth activities in the Village it was decided via social media to see if there was any interest in linking up

with the Rhewl project which seemed to be gathering momentum and if the demand was there a possibility of arranging transport via the Community Council
