The meeting was chaired by G.C.Evans

Community Policeman – had sent an apology work load did not allow him to be present. There were no matter of concern to relay to PCSO

Presentation by Jeanette Smalls –Denbighshire County Council Youth Community Worker. Jeanette explained that the Youth Bus Service was temporarily out of use and DCC were looking at different models of providing this service - which is going to be challenging in current financial climate. Corey Williams (Project Worker) was visiting the area and would be attempting to recruit volunteers to work with DCC to re start Youth Service. There would be use of social media to promote the appeal also posters in the area and use of Llais Llandyrnog Voice.

Jeanette was asked to provide the cost of a package for a short period for consideration.

Confirmation of Minutes

Clerk was asked to correct the fact that 200 people were employed in Arla not 100 as recorded and request was made for copies of the Power Point presentation used by Arla

2.1) Lease for Pavilion – Lease provided for consideration and to be discussed at next meeting.

2.3) Clerk had ordered No Overnight Parking sign for Cae Nant and awaiting delivery and fixing

2.4) Gullies in Nant Glyd – DCC had a programme of gully emptying and the matter would be seen to in time

2.5) Members commented that the new 40mph limit had made a marked difference and 20 mph now in place outside the school – Fforddlas had requested 30MPH signage and DCC were considering the matter.

2.6) Christmas tree lights had been purchased – request that lights on village hall be in place by 4th December – members to meet 28th December at village hall to erect lights.

2.7) Matter of minimum wage was discussed and agreed to re visit when setting budget for 2016/17

- Notification of AONB meeting at Loggerheads 11th December – Cllr Parry to attend.
- Parc Ty'n Llan – concerns that non residents were using the area designated for Parc Ty'n Llan users – area an adopted highway and matter referred to DCC as the adopting authority.
- DCC – were considering fixing extra signage top and bottom of green land to rear of Glyn Arthur to deter 4 x 4 drivers.
- Update on Superfast Broadband in Llandyrnog – certain properties which would need FTTP (Fibre To The Premises) would not be live until at least December 2016 – BT at fault – were not aware of the condition of their infrastructure.
- Tesco Local Community Scheme – grant available for green/open area projects – rolling programme and CC would consider submitting application 2016
