Name of Town or Community Council: Llandyrnog Community Council

Introduction and Context

This report has been prepared in accordance with the Environment Wales Act 2016 Part 1 – section 6 – The Biodiversity and Resilience of Ecosystems Duty. The Community Council worked closely with One Voice Wales and Denbighshire County Council on delivering biodiverse actions within the ward.

Llandyrnog community is within the Clwydian Range and Dee Valley National Landscape area which promotes a dark skies environment and as such planning and other considerations were taken in accordance with these bodies and published Supplementary Planning Guidance.

The administrative area of Llandyrnog Community council covers a large area of diverse habitat comprising farmland, hilltop moorland, a river valley, wooded areas and a number of dwellings of a range of ages, together with community buildings and land within the village itself.

The population was 1103 at the 2021 Census.

The Llandyrnog Community Council precept for the year 2025-26 was £12993 This amount was based on residential properties within the community and equated to a figure of £24.29 per household on and equivalent of Band D Council Tax.

The Community Council has responsibility for:

Land at Cae'r Nant – approx. 3.5 acres - used as a football field, children's play area and community space. This includes a wildlife bee-friendly planting bed and some areas planted with bulbs. The site is currently a mowed area and recently a tree was removed due to die back.

Land at Parc Ty'n Llan was given over to the community on completion of the housing estate on former farmland. This is currently a mowed area and used on an intermittent basis by local families.

The Cocoa Rooms , a community building dated back to 1885 which has no outside space but could be used to house habitat boxes.

The community council also worked closely with the County Council to promote the use of a small allotment area at Nant Glyd and worked closely with Ysgol Bryn Clwyd to improve biodiversity on their large primary school site off the B5429.

The community council sited two benched seating areas – one on the B5429 (opposite the Old Creamery – now a Proctor Johnson factory) and one on the crossroads of Groes Efa and Ffordd Las.

The community council provided planters on the roundabout entering the village on the B5429 and supported the local "Friendship Group" in planting and maintaining hanging baskets around the village .

The council set aside £3600 a year to maintain the land it owned as well as the Cocoa Rooms and upkeep of the church graveyard.

The council worked closely with other community groups to gain grants and provide support to maintain all of the biodiverse areas within the council's area.

The council is subject to the Well Being of Future Generations Act and as such consulted with stakeholders within the community to improve all aspects of the ward. This included increasing biodiversity through the planned activities within the council's business plan.
