1.0)Community Policeman – was not present and did not send an apology.

The Clerk was asked to contact the CPSO to relay concerns that some traffic seemed to be ignoring the 40mph and 20mph (advisory) and whether it would be possible either to monitor the speed in conjunction with DCC or if resources allowed increase their presence at times especially around peak traffic around the school

3.1) Lease for Pavilion – Lease for pavilion was considered and with minor amendments was ready – Clerk to arrange meeting between LSFA and CC representatives

proposal	Variation of condition no 12 of planning permission code 18/2012/1595 to allow 2 no access points to remain open
location	Highfield Park,Llangwyfan
CC observations	Repeat application to seek permission to leave two additional access to the complex open – the applicants had agreed initially under 18/2015/1146 that these access were not required and therefore CC unable to support the application as presented – the narrow lane between the access in question was not suitable for additional traffic and the complex able to function perfectly well without the need to retain the access referred to.

- 8.1) Report of excellent concert at Village Hall bu School – Clerk to write to thank to Mr Montrio and Staff

- 8.2) Parking at Parc Ty'n Llan – apparently commercial vehicles were being parked in front of some houses in Parc Ty'n Llan and members were informed that there was a covenant prohibiting this. Clerk advised that if the vehicles were parked on unadopted highway then it was a civil matter between the respective house owners and developer to ensure that the covenants were adhered to and not a matter for the Community Council.
 - 8.3) Gully outside waste treatment plant – surface water had scoured the tarmac – Clerk to relay to DCC
 - 8.4) BT chamber and gully outside Telephone exchange – Clerk had already reported matter but would report the matter again.
 - 8.5) Trees by bungalow at Nant Glyd – resident had concern – Clerk to relay to DCC Housing.
 - 8.6) Request to plant tree to replace the tree removed from Cae Nant – Clerk to seek prices
 - 8.7) Footpath between Glanrafon and Glanrafon Cottage was dangerous and needed cleaning – Clerk to relay to DCC
