CC observations	Original application submitted under code ref:18/2015/0122 for alteration and extension however was refused and applicant advised to apply for new dwelling. Concerns that the applicant was allowed to continue with his project despite being refused and that no enforcement action was taken. Also concerns about the lack of track to the garage

Cllr Parry declared an interest in the above application and was not part of the discussion or decision
