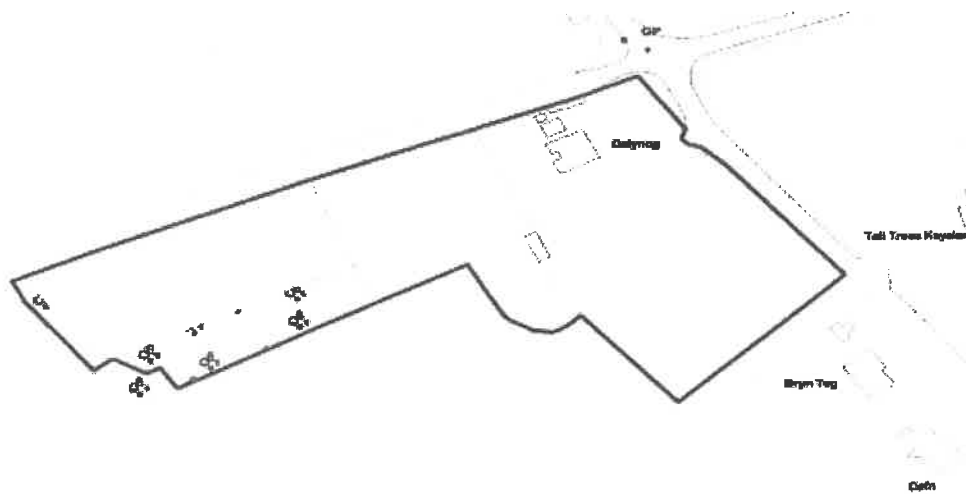

8.Planning Matters

Cllr Parry declared an interest in the matter of the additional candidate sites.

Two further candidate sites in the Llandyrnog area had been forwarded to DCC during the consultation period and DCC had forwarded them for Community Council consideration as to whether they would support

Members were unable to support the inclusion of these sites as possible candidate sites since they are deemed to be in the open countryside and no demonstrable evidence of local need had been submitted to the Community Council and that the candidate sites previously supported would be adequate for Llandyrnog for the life of the proposed Local Development Plan

Members Items

- Concerns had been raised that dogs were allowed off lead at Llangwyfan Woods and there may be a conflict between horse riders and dog owners – it was felt that this was not an issue for the Community Council and the Council would remain neutral on the situation and that individuals

who were concerned about the current arrangement should contact the Countryside Warden either as individuals or a Representing Body

- Concerns raised by horse riders that dogs were being allowed to run off lead on country lanes – this was discussed and although probably unwise for dog owners to let dogs off the lead on a highway it was not illegal - unless the dogs were out of control
- Reference to sad loss of the local Postman – Fred – Hazel to write to the Family on behalf of the Community Council – Fred seemed to serve Llangwyfan area.
- Roads that needed re surfacing – prepare list for next month's meeting
