Feb 23rd – e mail from Mr Morris

'I have just read the January minutes for the Community Council which are now on line and note that there is no mention of the £1000 grant that was proposed and as far as I recall agreed by the council towards Right of Way work carried out by the local authority'

Members agreed that the £1000 was not a grant but an item that had been included in the approved draft budget and had been properly recorded.

- Llangwyfan Crossroads white lining had been carried out
- Pothole by Cefn Bithell had been repaired
- Gullies by Maes y Wern had still not been emptied Clerk to remind DCC
- Defective gutter on 3 and 4 Clwyd Terrace had been reported to Estate but work outstanding

8.Reports

Cllr Rowley Williams had attended a virtual meeting of the Ruthin Hospital League of Friends who had confirmed that despite some work being delayed because of covid issues the extensive building and refurbishment works would be completed by December 2021

Cllr Thomas reported that following a recent Governors meeting the School was in a strong financial position and pupil numbers rising

Cllrs Butler and Williams had attended a virtual meeting of the MHC Liaison Group – the new Chief Executive Mr Kelly was keen to maintain a good relationship with the community and was committed to addressing the matters of concern mainly traffic at change of shift times, inappropriate disposal of PPE equipment around MHC and improved signage in the area to ensure that parcels were delivered to the MHC correct houses within the complex and not the surrounding properties which shared the same postcode.
